

USER AGREEMENT CAD DATA

Download CAD data

- The aim of BIG Kaiser (BKCH) is the continuous development and improvement of products. We therefore reserve the right to deliver products that deviate from the tools shown in the product data for the purpose of improvement.
- The user is requested to always check the respective specifications or data with regard to the intended use.
- By downloading the CAD data (WEB, Mail), the user declares his agreement with this user agreement.

Rights of use

- All rights, in particular the rights of use and exploitation under copyright law, to the CAD data made available shall be exclusively vested in the copyright holder in relation to the user.
- BIG KAISER grants the user the non-exclusive, non-transferable, temporally and geographically unrestricted right to download the CAD data provided from the website or the online store, the mail in unmodified form to the IT infrastructure (computer, server) used by him and to reproduce it for his own business purposes and to use it with the processing programs for CAD data employed by him. The user receives these rights free of charge.
- The user is not entitled to grant sublicenses. Furthermore, the user is not entitled to allow third parties to access the CAD data or to publicly distribute or make the same accessible
- The user is prohibited from changing or removing copyright notices, trademarks or other marks and information in the CAD data

Further obligations of the user

- The user shall store the CAD data downloaded by him as well as any access authorizations such as user names and passwords in such a way that access by unauthorized third parties is excluded.
- The CAD data may not be used by the user as a starting point for own developments of tools
- The use of the CAD data is at the user's own responsibility. Before using the CAD data, the user must carefully check whether the CAD data is suitable for his own purposes

Liability

• The granting of free CAD data use is done as a gesture of goodwill and at the user's own risk. The author assumes warranty and liability only in the case of intent and gross negligence or through the violation of an obligation essential to the execution of the contract. Liability for consequential damages resulting from the use of the retrieved third-party data cannot be assumed. Otherwise, the warranty and liability are excluded.

Changes

 BIG KAISER reserves the right to change, delete or restrict the CAD data provided for download at any time without further notice.

Salvatory clause

- Should individual provisions of this agreement be ineffective or incomplete, or should their fulfillment become impossible, the effectiveness of the remaining parts of the agreement shall not be impaired thereby.
- In this case, the PARTIES undertake to immediately replace the invalid provision by a permissible valid provision which, in terms of its content, comes as close as possible to the original intention.

Applicable law / place of jurisdiction

- This User Agreement shall be governed by and construed in accordance with the substantive laws of Switzerland, without giving effect to its conflict of law provisions.
- Any disputes arising out of or in connection with this User Agreement shall be subject to the exclusive jurisdiction of the ordinary Swiss courts having jurisdiction over the registered office of BIG KAISER.
